1 Procedural matters.

(a) Apologies: Cllr T Warden

(b) Declarations of interest. Cllr J Pemberton has shares in B4RN.

(c) Confirmation of the minutes of the Ordinary meeting of the Council held on Wednesday 15th July 2019. They minutes were agreed when the PC was quorate. It was proposed by Cllr J Tomlinson and seconded by Cllr J Pemberton to accept the minutes of the meeting as an accurate record. The Chairman signed a copy of the minutes.

(d) Dates of future meetings.

(e) Councillor vacancy. Tracey Royle has offered to become a Cllr for Capenhurst. This will be actioned at the next meeting. It was proposed by Cllr Tomlinson and seconded by Cllr Foster that Mrs Christine Pemberton is co-opted onto the Parish Council as a member for Capenhurst.

ACTION: Mrs Royle to be co-opted onto the council at the next meeting. Clerk to bring acceptance of office and members interest forms to the next meeting.

(f) Document storage. Grace Fogg confirmed the documents can be stored at URENCO. They will be stored in a secure vault and locked away. Written notice will be required for access.

2. Community engagement/Communications

(a) Urenco representative.

Mr Fagan agreed to planting a wild meadow question on the Green

Mr Fagan reported that the strimmers cut the green and surrounding URENCO land Thursday and Friday. The wood carving will be ready and installed later in the year on the green.

The concrete base for the speed camera will be in place later this year.

The Tails management facility is completed and is ready for the six month trial.

Old BNFL buildings will be demolished the site is being landscaped. Cheshire wildlife were suggested as advisors for this work to encourage indigenous creatures. Waste are on order for various sites around the villages.

Reports of raw sewage being found in ditches owned by URENCO. CWAC environmental health, United Utilities have been out to Fox Covert and advised accordingly. All drains in the site and on the sports ground have been cleared and rodded, Unfortunately, there are still drainage issues with flooding etc. The ditch goes out towards Foxall Way.

Mr Fagan reported that noise monitoring equipment is turned on between the hours of 1.00am and 2.00am. The equipment is towards Foxall Way. It was suggested that the equipment is sited towards the sports field as complaints have been received. Action:Clerk to write to CWAC Environmental Health and the national agency copying in resident who reported noise disturbance.

Pavements in Ledsham Mr Eardley has raised this with the CWaC Highways Department and await their response as to whether pavements in Ledsham are scheduled for current resurfacing works as part of the rolling programme.

Obstruction of cars on Hollybank - when visiting the siteMr Eardley saw some of the parking challenges and took some images which he passed on to PC Rob Brown and PCSO Wendy Leason.

ACTION: Clerk to write letters to residents parking on the pavement.Cllr Pemberton to deliver letters.

A550 speeding - Cllr Eardley has raised this matter with PC Brown and PCSO Leason and they have responded saying the A550 is a national speed limit road and they will not carry out any roadside speed checks on that road as it is not safe to do so as there is no safe space to stand.

Dumping of material at a field in Ledsham Lane (related to the 'Springfields' property) Cllr Eardley has reported this to CWaC Planning Enforcement.

Field on Chapel Lane (down from the chapel) -Cllr Earldey has concerns with CWaC Planning regarding hard standing material and containers that have been placed on this site.

(d) Members of the public speaking time. Residents expressed concerns about speeding traffic on the A550. Also the Ledsham lane coming from Hooton at Two Mills has no 50mph lettering on the road in the outside lane.

It was noted that Mrs Atkinson maintains the grass outside her property in Ledsham Village up to Ledsham Lane.

Continuing flooding in Penfold Close and on the bend opposite Holy Trinity Church. It was noted that the drains in Capenhurst to the railway station have collapsed.
